— IMPACT —

Through the dedicated work of the SOAR TA Center, state and local SOAR Leaders, and SOAR-trained case workers, the SOAR model has assisted over **105,013 people*** who were experiencing or at risk of homelessness to apply for SSI/SSDI benefits, enabling these individuals to obtain stable housing, receive mental health and substance abuse treatment, and pursue their vocational goals. Among these individuals, **65,372 people*** are receiving benefits because of SOAR.
